Disclaimer, Release, Waiver, and Indemnity

In consideration of Edmonton Airport Authority, 4 Wing Cold Lake, Epcor Genesee Power Project and any private landowner and/ or outfitter allowing me to enter onto their respective wilderness properties ("Wilderness Property") for the purpose of hunting wildlife (the "Activity"), and in consideration of Alberta Hunter Education Instructors' Association (AHEIA), Alberta Professional Outfitters Society (APOS) and Hunting for Tomorrow (HFT) organizing the Activity, I hereby agree as follows:

I acknowledge that the Activity is potentially a very hazardous activity.

I fully acknowledge that neither Edmonton Airport Authority, 4 Wing Cold Lake, EPCOR Genesee Power Project, any private landowner and/ or outfitter, Alberta Hunter Education Instructors' Association (AHEIA), Alberta Professional Outfitters Society (APOS) or Hunting for Tomorrow (HFT) have made any representations, warranties or assurances, whether written or verbal, express or implied, about the Activity, the physical conditions or suitability of the Wilderness Property for the Activity, or my personal safety or security while engaging in the Activity.

I agree that I am responsible for my own personal safety and security and the safety and security of others while on the Wilderness Property. I agree to take all reasonable and prudent precautions to ensure my own personal safety and to decrease the risk of injury, death, or property damage to any other parties that might coincidentally be on the Wilderness Property.

I hereby voluntarily assume any and all risks associated with the Activity on the Wilderness Property, including, without limitation, bodily injury, death and property damage, all such risks being known and appreciated by me.
